Sub: **Summary Revision of last part of electoral rolls relating to Service Voters with reference to 01.01.2013 as qualifying date.**

Sir / Madam,

Please find enclosed herewith letter No.24/2012-ERS/Vol-II dt.10.10.2012 of Election Commission of India, on the above subject. The Commission has decided to undertake summary revision of last part of electoral rolls relating to Service Voters with reference to 01.01.2013 as the qualifying date. The Commission has further ordered that Summary Revision of the last part of the electoral rolls relating to Service Voters, to make the same up-to-date, by enrolling all other eligible service voters who would be of 18 years age or more as on 01.01.2013 (i.e. born on or before 01.01.1995) and those who could not apply for such registration in previous years due to frequent postings or any other reasons or those who wish to change their earlier declarations.

2. The Commission has directed that the record offices / authorities should obtain the Forms and declarations from all the aforesaid service voters and after due verification, forward them to the District Election Officer/Electoral Registration Officer.

3. The names of only those service voters whose statements are received by the Electoral Registration Officers through the CEO/District Election Officer should be included in the last part of the electoral roll. The 1st Supplement of the last part of electoral roll so prepared with reference to 01.01.2013 shall be printed.


4. The forms of service voters received by EROs after 31st December, 2012 will be incorporated in the 2nd Supplement to be brought out on 30th June, 2013 as a process of continuous updation.

5. All EROs should forward extracts from the roll pertaining to each record office to the record offices concerned latest by 28th February, 2013 in respect of the 1st Supplement and , wherever necessary by 31st July, 2013 in respect of the 2nd Supplement.

6. The existing last part of the electoral rolls relating to service voters has been uploaded and this can be accessed by the Electoral Registration Officer

through the ERMs Software. You are requested to update the same and after completion of updation, the concerned computer firms may be directed to print and supply 8 (eight) copies of the last part of the electoral roll. Since the updation requires data entry in English only, this work can be done in the EROs office.


