Special Summary Revision of Electoral Roll -2013 – Points for
priority intervention by the DEOs.

Sir/Madam,

1. The Special Summary Revision -2013 which is in progress now has been taken up primarily to correct the EP Ratio and to ensure that 100% voters have their photographs in the Electoral Roll.
2. During the review meeting which was taken up on 15th May, 2013 by the Deputy Election Commissioner, Election Commission of India, it was seen that the progress of identification for deletion and collection of photographs as reported by the DEOs was still not satisfactory.
3. As against the possible excess of about 32 lakh voters, about 9.6 lakh (30%) voters had been identified for deletion as per the reports till 14th May, 2013. Similarly, 5.4 lakh photographs (about 20%) were reported to have been collected against the non PER of 28 lakh.
4. As the Election Commission is insisting 100% PER and EP Ratio to come closure to the census figure, on the request of the DEOs during that meeting, the proposal for extension of Special Summary Revision 2013 has been sent to Election Commission, where it is proposed to extend the period of filing claims and objections up to 31st May, 2013, disposal of claims and applications by 10th June, 2013 and final publication on 1st July, 2013.
5. This extended period has to be effectively used to achieve the above two objectives.
6. The DEOs can monitor the progress of household to household survey, collection of form 6,7 & 8 and handing over of forms to the Vendors and data entry of form 6,7 & 8 using the web based monitoring system in the CEOs website (guidelines for using the web based ERMS monitoring system is enclosed at Annexure – I).

7. The EP Ratio reduction is highly un-satisfactory in Bolangir, Nayagarh, Kendrapara, Puri, Khurda, Dhenkanal & Cuttack districts.
8. Collection of photographs is lagging behind in Khurda, Malkangiri, Nabarangpur, Puri, Jajpur and Nayagarh districts.
9. You are advised once again to use the web based Electoral Monitoring System and ensure timely updation of data including the entry of all the forms in the CEOs website as the disposal of forms can be taken up only after all the forms are in the public domain in CEOs website for minimum seven days.
10. You must also work out your strategy for 100% collection of photographs and starting of suo-moto cases for deletion of duplicate or shifted voters as per the data collected by the BLOs. It is reiterated that bringing down of the EP Ratio from 68.6% for the State nearer to Census figure of 61.08% is most essential objective of the present Special Summary Revision. The finalization of the rolls for this revision will be cleared by the Election Commission subject to bringing down the EP Ratio nearer to the Census figure.

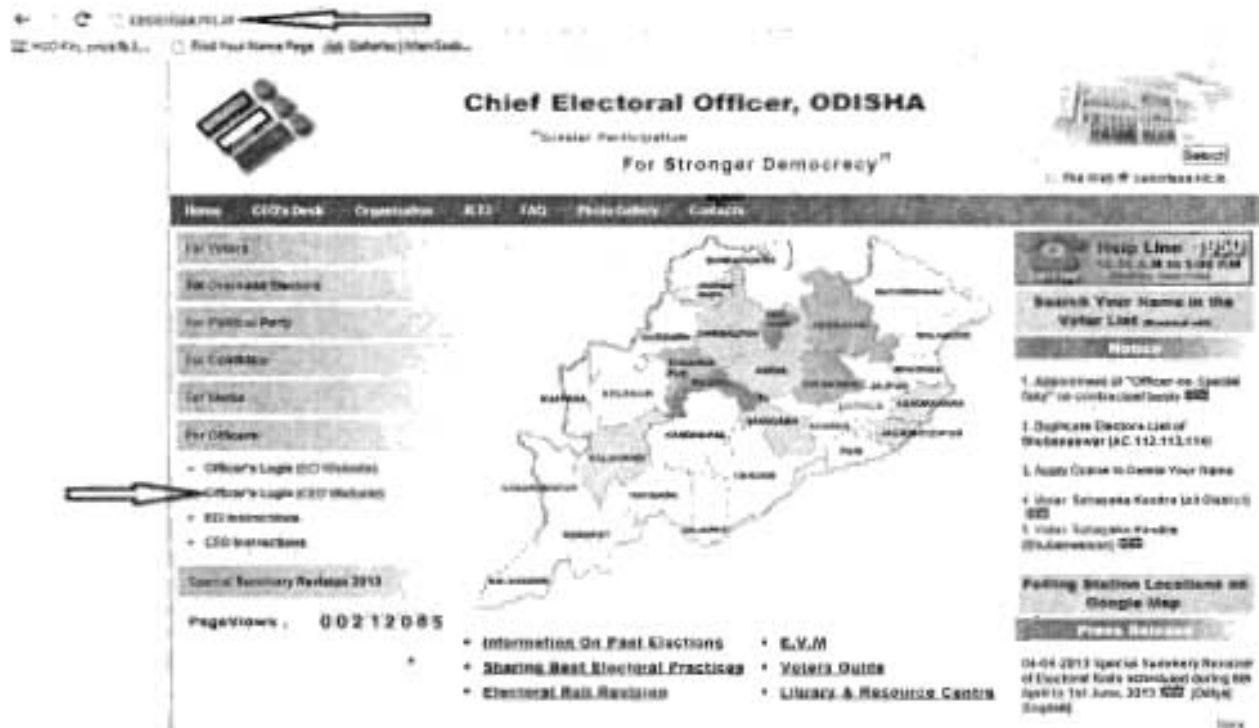

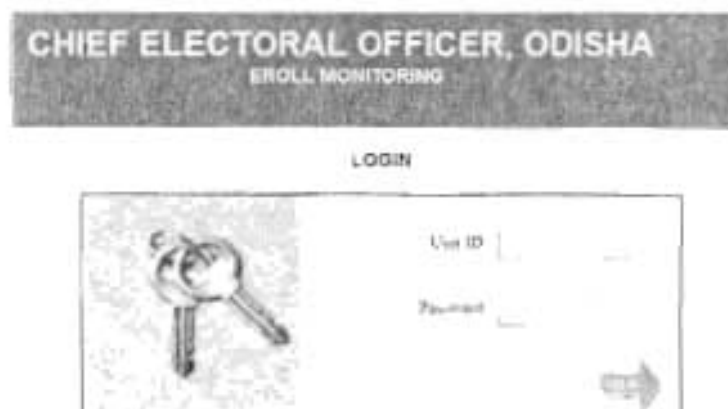
