Sub: **Special Summary Revision of Electoral Rolls 2013- feedback of officers during field visits on Special Campaign day**

Sir / Madam,

I am to say that basing on the feedback of the officers of this Department during visits to the Polling Stations on the first Special Campaign day, the following actionable points have been identified:

- i. It was reported by BLOs of AC No. 92 Niali (SC)- Part No. 215, 216, 217, 218, 220 & 221 and AC No. 112- Bhubaneswar (Central)- Part No. 19, 20, 21, 22 & 23 that certain additions, deletions and corrections submitted by them during the last Special Summary Revision (April-July 2013) have not been incorporated in the current Draft Roll 2014.


All the pending applications in Form-6 which were not disposed of during the last revision should be disposed on merit during this on-going revision. It should also be ensured that proper action is taken on all pending deletions identified by the BLOs. It should be checked that all corrections suggested by the BLOs in the working copy are effected in the data base by the computer firm during the on-going data entry. Photographs of non-photo electors which were collected during the House to House visits but not merged in the database should be merged immediately.

- ii. A schedule may be drawn up in consultation with the computer firms so that the BLOs can verify and satisfy themselves that all additions, deletions and corrections submitted by them are entered in the data base and if any application is rejected, then the reasons for rejections should be made known to the BLO, so that they can inform the applicant accordingly.

- iii. EROs should draw up a programme during 25th -30th November 2013 for 100% verification by BLOs of the data entry done by the computer firms so that (a) errors, if any, can be corrected (b) omissions, if any, can be incorporated.
- iv. An interaction with political parties to keep them updated on the ongoing roll revision programme should be held, if not already conducted. Copies of the draft electoral roll should be handed over to authorized representatives of political parties.
- v. The applications in Form-6 for inclusion of name received through academic institutions, at the Voter Sahayata Kendra should be separately shown while updating data in Form-3 (Summary Revision) on ECI's website.
- vi. It should be ensured that adequate publicity is given to the revision programme by way of press meet, programmes of Cultural troupes at the haat level, affixing flex banners in offices and other conspicuous places, posters in every polling station, scrolling news and creating voters awareness utilizing the video spot and audio jingles circulated by this Department.

The above instructions may be brought to the notice of all concerned.


