Sub: **Special Summary Revision of Electoral Rolls 2014- disposal of pending claims and objections relating to last Summary Revision held in April- July 2013**

Sir / Madam,

It has come to notice that in several Assembly Constituencies, there are pending applications in Form-7 for deletion and electors identified by BLOs for deletion for reasons of death, shifted and repeat entries which have not been entered in the ERMS database during the last Special Summary Revision of Electoral Rolls undertaken during April- July 2013. In certain cases, the BLOs are stating that all the electors they had suggested for deletion have not been deleted, and names of some electors still find place in the current Draft Electoral Roll- 2014.

2. Since the information has been collected by BLOs during House to House visits, it should be verified whether there are any pending Form-7 received during the last Summary Revision. If so, these applications should be disposed of following due procedure during the ongoing Revision, and data entry made in the ERMS so that names of such electors are deleted from the rolls. **It should also be checked whether there are any left out cases of deletion reported by the BLOs in their working copy.** This can be verified with reference to deletion list of Supplement 3 and 4. **These left out deletions should be identified latest by 21st November 2013 so that the same can be deleted from the electoral roll during the ongoing Summary Revision.**

3. Similarly, it should be checked whether there are any **left out photographs of non-photo electors** which were collected during the House to House visits (in April-July 2013) but have not been merged in the database. They should also be handed over to the computer firm for merging in the database.

4. This exercise should be taken up immediately, and information in the following proforma should be updated on www.ceood.blogspot.in by **21st November 2013 evening positively**. If the information is nil, then it should be entered as '0' (Zero). The same will be reviewed in a video conference scheduled to be taken on 22.11.2013.


