Schedule for Special Summary Revision Electoral Rolls w.r.t. 01.01.2014 as the qualifying date- extension of period of filing of claims and objections


Sir/ Madam,

I am directed to say that in order to give the public adequate opportunity to file their claims and objections, Election Commission has been pleased to extend the last date for filling claims and objections from **17.11.2013 to 23.11.2013 (Saturday)** for 28 districts (except Ganjam & Balasore). The last date for data entry of claims and objections and disposal of the same has been extended to 30.11.2013 and 10.12.2013 respectively as indicated in the table below. The final publication of Electoral Rolls will be made on 06.01.2014 as approved by the Commission earlier.
