The 15th March, 2014

No. 3900-VE(A)56/2014/Elec.— WHEREAS, in accordance with the provisions of clause (1) of Article 172 of the Constitution of India, the existing Legislative Assembly of the State of Odisha, unless sooner dissolved, shall continue up to and including the 7th June, 2014 and shall, thereafter, stand dissolved on the expiration of its duration; and

WHEREAS, in terms of sub-section (1) of Section 15 of the Representation of the People Act, 1951 (43 of 1951), a General Election has to be held for the purpose of constituting a new Legislative Assembly of the State of Odisha;

NOW, THEREFORE, as recommended by the Election Commission of India, in pursuance of sub-section (2) of Section 15 of the Representation of the People Act, 1951 (43 of 1951), the Governor of the State of Odisha is hereby pleased to call upon each of the Assembly Constituencies of the State of Odisha, specified in the Table below to elect members to the Legislative Assembly of the State, in accordance with the provisions of the said Act and of the rules and orders made there under:
