### NOTIFICATION

**No.100/ECI/NOTI/TERR/ES-II/OR-LA/1/2019: WHEREAS**, the seat of Shri Naveen Patnaik, in the Legislative Assembly of the State of Odisha, elected from 2-Bijepur Assembly Constituency has fallen vacant on 2<sup>nd</sup> June, 2019 by reason of his resignation; and

2. **WHEREAS**, a bye-election is required to be held for the purpose of filling the vacancy so caused;

3. **NOW, THEREFORE**, in pursuance of sub-section (1) of Section 150 and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-

**(A) Calls upon** the said **2-Bijepur Assembly Constituency** in the State of Odisha, to elect, before the 27<sup>th</sup> October, 2019 (Sunday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Assembly of the State; and

**(B) Appoints**, with respect the said election:-

- a) the 30<sup>th</sup> September, 2019 (Monday), as the last date for making nominations;
- b) the 1<sup>st</sup> October, 2019 (Tuesday), as the date of scrutiny of nominations;
- c) the 3<sup>rd</sup> October, 2019 (Thursday), as the last date for withdrawal of candidatures;
- d) **the 21<sup>st</sup> October, 2019 (Monday), as the date on which a poll shall, if necessary, be taken; and**
- e) the 27<sup>th</sup> October, 2019 (Sunday), as the date before which the election shall be completed; **and**

**(C) Fixes the hours from 07.00 AM to 05.00 PM**, as the hours during which the poll shall, if necessary, be taken on the date specified above for the bye-election.
